NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that

Mary Corrigan, PhD., is hereby appointed to the Sedgwick County Advisory Council on Aging, effective April 12, 2017. The term of this appointment shall expire June 30, 2019, except that in the event the Commissioner making the recommendation for the appointment herein leaves office for any reason, the said term shall expire and the member shall then serve until a successor has been duly appointed.
