That for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations, the receipt of which is hereby acknowledged, the undersigned, Unified School District #260 being the owner of the following described real estate in Sedgwick County, Kansas, to wit:

A portion of the East Half of the Northwest Quarter of Section 23, Township 28 South, Range 1 East of the Sixth Principal Meridian, Sedgwick County, Kansas, described as follows:

Commencing at the southeast corner of said Northwest Quarter; thence, along the south line of said Northwest Quarter on an assumed bearing of S88°41'06"W, 234.14 feet; thence, N01°18'54"W, 156.36 feet to the north line of an existing drainage easement and being the Point of Beginning; thence, N14°23'45"W, 796.67 feet; thence, N75°36'15"E, 15.00 feet; thence, N14°23'45"W, 415.11 feet; thence, N75°36'15"E, 140.00 feet to the west line of an existing drainage easement; thence, along said west line, S14°23'45"E, 415.11 feet; thence, continuing along said west line, S75°36'15"W, 15.00 feet; thence, continuing along said west line, S14°23'45"E, 829.20 feet to the north line of said existing drainage easement; thence, along said north line, S88°41'06"W, 143.73 feet, to the Point of Beginning.

The above described contains 3.947 acres, more or less.


