Jacques: Thank you for attending the meeting last night. I didn't see you when I left and don't know if you stayed for the entire meeting. There was no winning on the Wetland Park Trail. The other issue on the agenda that affected annexed areas was the animal fees. The animal ordinance was revised two weeks ago and council was never given a line by line list of what was changing, even though Al and myself both asked. We were told it was to complex for us to understand. Al referred to it as a Trojan Horse and asked what they were hiding. Well, the horse was exposed last night. The new fees were voted on. Supposedly due to increase in costs all fees had to be raised, but the only ones that were raised are for horses, cattle, livestock and chickens. These only affect the annexed areas and were increased 5- 10 fold. A chicken permit was 2.50 and was raised to 25.00 per chicken, horse and livestock \$25 to \$125 per animal. After much debate the fees were lowered to just triple, with horses/livestock now \$75 and chickens \$15, and that was still a 4/4 vote with the mayor breaking the tie.

Staff will not and cannot answer questions. Information that is provided is inaccurate and at times completely false. I've fought hard for 6 years and it has taken a great toll on my health. My husband and I planned on moving to Utah at the end of my term but after losing my job in February we decided to go ahead and retire early and enjoy the time we can. I quit the council last night—he will leave the planning commission next week. I do not feel happy about this and have great regrets in leaving those that I wanted to help, but it has become impossible to work within the current system and I don't have the energy it will take to wait another two years. Thank you for your support over the years.

I will still help in anyway that I can. Mr. Herr has asked to speak with me in regards to the de-annex issue. I've already had many conversations

with commissioners Skelton, Peterjohn and Ranzau. This new issue with tighter animal controls and fees for annexed areas will aid somewhat in that it shows an unequality within the city/annexed areas.
