

RESOLUTION

A RESOLUTION PROVIDING FOR THE ALTERATION OF COUNTY COMMISSIONER DISTRICT BOUNDARIES WITHIN SEDGWICK COUNTY, KANSAS

WHEREAS, Sedgwick County, Kansas is divided into five county commissioner districts that were last defined, established and adopted by Sedgwick County Resolution No. 209-03; and,

WHEREAS, pursuant to K.S.A. 2010 Supp. 19-204, the county commissioner districts are required to be as compact and equal in population as possible; and,

WHEREAS, due to changes in population within Sedgwick County, it is necessary that the county commissioner district boundary lines be altered to be in compliance with said law.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS:

SECTION I. County commissioner districts shall be numbered One through Five, inclusive, and they are hereby established according to the boundaries of voting precincts which exist at the date hereof and which are identified by number on attached "Exhibit A". The new county commissioner districts are generally depicted in a map described as "_____", (dated _____), which map is attached hereto as "Exhibit B". Both Exhibit A and Exhibit B are incorporated herein by reference.

SECTION II. The Board of County Commissioners hereby finds and determines that, after examining all of the relevant facts and data available, and after having received online public comment and testimony, the commissioner district boundary lines as established herein are, in accordance with K.S.A. 2010 Supp. 19-204, as compact and equal in population as possible.

SECTION III. The alteration of commissioner district boundaries as hereinabove established shall be effective from and after the adoption of this resolution.
