

RESOLUTION NO. ____-2016

A RESOLUTION APPROVING AND AUTHORIZING AN AGREEMENT FOR ENHANCED AUTOMATIC AID RESPONSE BETWEEN THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY ACTING AS THE GOVERNING BODY OF SEDGWICK COUNTY FIRE DISTRICT NUMBER ONE AND THE CITY OF DERBY, KANSAS, IN ACCORDANCE WITH THE PROVISIONS OF K.S.A. 19-3608

WHEREAS, K.S.A. 19-3608 authorizes fire districts to contract with a city having an organized fire department in its county for fire protection services and for the use, operation, care and maintenance of any fire apparatus or equipment belonging to such district by said city upon the passage of a resolution by the County and an ordinance by the city authorizing the same; and

WHEREAS, the Board of County Commissioners of Sedgwick County, Kansas, as the governing body of Sedgwick County Fire District Number One and the City of Derby, Sedgwick County, Kansas have previously entered into a Mutual Aid Agreement and an Automatic Aid Agreement for structure fires for the provision of fire protection services within both jurisdictions by both entities; and

WHEREAS, the Board of County Commissioners of Sedgwick County, Kansas, as the governing body of Sedgwick County Fire District Number One and the City of Derby, Sedgwick County, Kansas desire to enter into a contract for the purpose of establishing an Enhanced Automatic Aid Response System to regulate certain operations involving both Sedgwick County Fire District Number One and the City of Derby.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF SEDGWICK COUNTY FIRE DISTRICT NUMBER ONE THAT:

Section 1. Authorization

In accordance with the provisions of K.S.A. 19-3608, Board of County Commissioners of Sedgwick County, Kansas, as the governing body of Sedgwick County Fire District Number One hereby approves and authorizes the Fire District to enter in to and the Chairman to execute an Agreement for Enhanced Automatic Aid Response with the City of Derby, Sedgwick County, Kansas, for the purpose of establishing an Enhanced Automatic Aid Response System to regulate certain operations involving both Sedgwick County Fire District Number One and the City of Derby.

Section 2. Effective Date

This Resolution shall take effect and be in force from and after its passage.
