**A RESOLUTION APPOINTING DUANE SCHNEIDER AND RE-APPOINTING MEMBERS CASEY BELKNAP, TIM LENZ AND BRAD RAGLAND TO THE SEDGWICK COUNTY AND CITY OF WICHITA JOINT BOARD OF ELECTRICAL APPEALS**

**WHEREAS**, the Board of County Commissioners adopted Resolution No. 135-2012 on August 29, 2012 and the City of Wichita adopted City Ordinance No. 49-333 on August 21, 2012, agreeing to consolidate the Board of Electrical Appeals (“Joint Board”);

**WHEREAS**, the Board of County Commissioners adopted the Wichita-Sedgwick County Unified Building and Trade Code (“UBTC”) on November 21, 2012, and the City of Wichita adopted the UBTC on December 4, 2012;

**WHEREAS**, Article 1, Section 5 of the UBTC provides for the terms of appointments to said Joint Board;

**WHEREAS**, Article 4, Section A of the UBTC authorizes said Joint Board and the qualifications for members of same;

**WHEREAS**, it is the desire of the Board of County Commissioners that the following members be reappointed and newly appointed, as indicated below, to the Joint Board and that the terms of said members shall be two years from the effective date of appointment.

**WHEREAS**, it is the desire of the Sedgwick County Board of County Commissioners to appoint Duane Schneider to replace Richard Kretchmar in the Master Electrician position as Mr. Kretchmar resigned effective April 11, 2017, and that resignation was accepted by the Sedgwick County Board of County Commissioners on April 19, 2017; and

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:**

The following individuals are hereby re-appointed as Sedgwick County Board of County Commissioners' re-appointments to the Joint Board:

The terms of the appointments and reappointments herein shall be two years from August 2, 2017, the effective date of appointment, or until a successor has been appointed, qualified and sworn to the oath of office before the Sedgwick County Clerk.

**BE IT FURTHER RESOLVED** that the members appointed and re-appointed herein shall take and subscribe the oath of office and file same with the Sedgwick County Clerk within twenty (20) days of the effective date of this appointment prior to assuming duties as a member of said Joint Board.
