**Project Description:** The District Attorney's office uses numerous types of equipment in the normal course of daily business. This request is for two separate equipment needs.

- 1) Blu-ray discs are being used by law enforcement and provided to the District Attorney as part of the overall law enforcement report with increased frequency. The rules of discovery require the District Attorney's office to provide defense counsel with 'discoverable' materials. If a case involves multiple defendants, then copies must be provided to each defendant's counsel. The discovery unit in the office currently uses (2) CD/DVD duplicators, but this device would provide the ability to burn multiple copies of Blu-ray discs where now the duplication is done one at a time within the individual's pc. Literally, thousands of discs are copied each year by a team of two discovery clerks. This device would not only provide Blu-ray capabilities, but also an additional duplicator for regular use due to its versatility of being able to duplicate CD/DVD/Blu-ray discs.
- 2) Two microphones, and batteries with rechargeable capabilities, for use with an existing HD video camera to provide better audio reception than the built in microphone can provide. The video camera is used regularly in depositions, interviews and training sessions.

The Toxicology Laboratory has two mass spectrometers that were purchased in 1999 and 2001. The Data Analysis systems are outdated and are no longer supported by the vendor. This system improvement will extend the useful life time of these critical instruments.

The current “fix” is to unplug a printer from one instrument and move it to another – this creates tremendous inefficiencies and slows down the testing process.
