**A RESOLUTION RE-APPOINTING REVEREND DAVE FULTON TO THE  
SEDGWICK COUNTY MENTAL HEALTH ADVISORY BOARD**

WHEREAS, the Board of County Commissioners of Sedgwick County, Kansas has established, pursuant to K.S.A. 19-4002a and Sedgwick County Resolution No. 199-1986 (and amendments thereto), a mental health advisory board to make certain recommendations regarding mental health services and programs in Sedgwick County;

WHEREAS, Sec. 14-76 of the *Sedgwick County Code* provides for the appointment of members to the Sedgwick County Mental Health Advisory Board;

WHEREAS, Reverend Dave Fulton is qualified to serve on said board, has served previously on said board and his term expired upon Commissioner Karl Peterjohn leaving office; and

WHEREAS, it is the recommendation of Commissioner David Dennis that Reverend Dave Fulton be re-appointed to the Sedgwick County Mental Health Advisory Board for a term of four years.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:

Reverend Dave Fulton is hereby re-appointed to the Sedgwick County Mental Health Advisory Board. The term of this appointment shall expire on April 11, 2021, or as otherwise provided in *Sedgwick County Code*, sec. 14-76.


