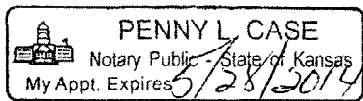

NOTICE OF HEARING

Take Notice that the Board of County Commissioners of Sedgwick County, Kansas (the Board) shall hold a hearing on the Petition for Transfer of Certain Land Comprising the Valley Township Drainage District to the Eagle Drainage District. The hearing will commence at 9:00 o'clock a.m. on the 11th day of May, 2011, at the Sedgwick County Courthouse, 525 N. Main, Wichita, KS, in the Board of County Commissioners meeting room #320. At that time, the Board shall hear testimony as to the advisability of granting the petition. The Board may continue the hearing beyond the time and date specified in this notice without further notice.

Legal Description:

Tract 1: Commencing at the Northeast corner of the Southeast Quarter (SE1/4) of Section 21, Township 24, Range 4 West, Reno County, Kansas, thence South along the East line of said Section 21 to a point where the Arkansas River intersects the East line of said Section 21, thence Northwesterly along the Arkansas River to a point on the West line of the East Half of the Southeast Quarter (E1/2 SE1/4) of said Section 21, thence North to the North line of the said Southeast Quarter (SE1/4), thence East to the point of beginning;

Tract 2: Commencing at a point where the Arkansas River intersects the West line of Section 22, Township 24, Range 4 West, Reno County, Kansas, thence North to the Northwest corner of the Southwest Quarter (SW1/4) of said Section 22, thence East to the Northeast corner of the West Half of the Southeast Quarter (W1/2 SE1/4) of Section 22, thence South to the South line of said Section 22, thence West to a point where the Arkansas River intersects the South line of said Section 22, thence Northwesterly along the Arkansas River to the point of beginning;

Tract 3: The East Half of the Southeast Quarter (E1/2 SE1/4) of Section 22, Township 24, Range 4 West, Reno County, Kansas; [this is a white space on color coded map]

Tract 4: Commencing at a point where the Arkansas River intersects the North line of Section 27, Township 24, Range 4 West, Reno County, Kansas, thence East to the Northeast corner of said Section 27, thence South to the Southeast corner of said Section 27, thence West to a point where the Arkansas River intersects the South line of said Section 27, thence Northwesterly along the Arkansas River to the point of beginning;

Tract 5: Section 26, Township 24, Range 4 West, Reno County, Kansas;

Tract 6: Section 25, Township 24, Range 4 West, Reno County, Kansas;

Tract 7: Commencing at a point where the Arkansas River intersects the West line of Section 36, Township 24, Range 4 West, Reno County, Kansas, thence North to the North line of said Section 36, thence East to the East line of said Section 36, thence South to the South line of said Section 36, thence West to a point where the Arkansas River intersects the South line of said Section 25, thence Northwesterly along the Arkansas River to the point of beginning;

Tract 8: All that part of the Northeast Quarter (NE1/4) lying North of the Arkansas River less road row, and all of Island lying North of the Arkansas River except road row, in Section 35, Township 24, Range 4 West, Reno County, Kansas; and Lot H8 and that portion of Lot B2 lying west of the half section line dividing the Northeast Quarter (NE1/4) and the Northwest Quarter (NW1/4) of Section 35, Township 24, Range 4 West, Reno County, Kansas.

This notice shall be published at least once each week for two consecutive weeks in a newspaper of general circulation in each drainage district. The last publication shall be at least 10 days, but not more than 20 days, prior to the date of the public hearing. The notice shall also be published in the official county newspaper once, at least seven days prior to the date of the public hearing. The cost of such publication shall be paid by the district which submitted the petition.
