RESOLUTION AUTHORIZING A FORGIVABLE LOAN TO  
QUALITY SOLUTIONS, INC. FOR ECONOMIC DEVELOPMENT INCENTIVES

WHEREAS, the Board of County Commissioners recognizes that economic development is essential for the economic stability of Sedgwick County; and

WHEREAS, an opportunity exists for County to retain QUALITY SOLUTIONS INC.'s ("QUALITY SOLUTIONS") operational facility in Sedgwick County through a forgivable loan, conditioned on local job retention and creation, for the purpose of expanding its capacity to provide facility maintenance and related services to national-level retailers in sectors such as telecommunications, stand alone retail, mall retail, financial services, food and beverage and automotive services. The company provides i) reactive maintenance, ii) preventative maintenance, and iii) project construction services; and

WHEREAS, the Board of County Commissioners, under its home rule authority granted by K.S.A. 19-101 et seq., and amendments thereto, is authorized to support economic development in Sedgwick County.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF SEDGWICK COUNTY COMMISSIONERS THAT:

1. The Board of County Commissioners finds that providing a forgivable loan in the amount of \$20,000 to QUALITY SOLUTIONS will advance economic development in Sedgwick County.
2. The Board of County Commissioners finds that such an expenditure of funds is for a public purpose.
3. The Chairman is authorized to sign all necessary documents and agreements that

support this objective, subject to review and approval of the Sedgwick County Counselor's Office.

4. This resolution shall take effect and be in force from and after its approval and adoption by the Board of County Commissioners of Sedgwick County, Kansas, and upon its publication once in the official county newspaper.


