**A RESOLUTION OF THE SEDGWICK COUNTY FIRE DISTRICT 1 APPROVING  
LEVY OF PROPERTY TAXES TO FINANCE 2017 BUDGET**

Whereas, K.S.A. 79-2925b, as amended, provides that a levy of property taxes to finance the 2017 budget of Sedgwick County Fire District 1 exceeding the amount levied to finance the 2016 budget of Sedgwick County Fire District 1 (as adjusted to reflect changes in the Consumer Price Index for All Urban Consumers for calendar year 2015), must be authorized by a resolution adopted in advance of the adoption of a budget supported by such levy; and

Whereas, K.S.A. 79-2925b, as amended, also provides that current year revenue that is produced and attributable to the taxation of (1) new improvements to real property, (2) increased personal property valuation, (3) property located within added jurisdictional territory, or (4) property which has changed in use shall not be considered when determining whether revenue produced from property tax has increased from the preceding year; and

Whereas, Sedgwick County Fire District 1 provides essential services to protect the citizens in the District; and

Whereas, the cost of providing these services continues to increase.

NOW, THEREFORE, BE IT RESOLVED by the Governing Board of Sedgwick County Fire District 1 that:

**Section 1.** A levy of property taxes for financing the 2017 budget in an amount which exceeds the amount levied to finance the 2016 budget, as adjusted pursuant to K.S.A. 79-2925b(a), as amended, is hereby approved.

**Section 2.** The Sedgwick County Clerk is directed to publish this resolution once in the official county newspaper. This resolution shall take effect upon its publication in the official county newspaper.
