**AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN
LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF
PARK CITY, KANSAS.**

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF PARK CITY,
