

EASEMENT FOR RIGHT-OF-WAY

THIS EASEMENT FOR RIGHT-OF-WAY, executed and delivered to Sedgwick County, Kansas (hereinafter, "County") by BRIAN E. ECK AND TAMI ECK, HUSBAND AND WIFE (hereinafter, "Owner").

WITNESSETH:

That for and in consideration of the sum of ONE DOLLAR AND NO CENTS (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, Owner hereby grants, bargains, sells and conveys to County a permanent easement in, over, across and upon the following-described premises, to wit:

A portion of the Southeast Quarter of Section 12, Township 27 South, Range 3 West of the 6th Principal Meridian, Sedgwick County, Kansas described as commencing at the northeast corner of said Southeast Quarter; thence south along the east line of said Southeast Quarter, 550.00 feet; thence west parallel with the north line of said Southeast Quarter 30.00 feet to the point of beginning; thence continue west parallel with the north line of said Southeast Quarter, 10.00 feet; thence south parallel with the east line of said Southeast Quarter, 91.28 feet; thence southeast, 51.33 feet to a point 30.00 feet west of the east line of said Southeast Quarter and 141.63 feet south of the Point of Beginning; thence north parallel with the east line of said Southeast Quarter, 141.63 feet to the point of beginning. Said tract contains 1164.4 square feet, more or less.

For the purposes of construction, reconstructing, widening, improving, draining and maintaining a road or highway.




