

EXHIBIT "A"

A tract in the South Half of Section 13, Township 29 South, Range 1 East of the 6th P.M., Sedgwick County, Kansas, described as commencing at the intersection of the South line of said Section and the Westerly right-way line of the A.T. & S.F. Railroad, said point being 2055.54 feet West of the Southeast corner of said Section 13; thence West along the South line of said Section 13, 1370 feet; thence with an angle to the right of 141°00', a distance of 340 feet; thence with an angle to the right of 18°00' a distance of 810 feet; thence with an angle to the left of 24°00', a distance of 190 feet; thence with an angle to the left of 33°00', a distance of 190 feet for the place of beginning; thence with an angle to the left of 38°00', a distance of 190 feet; thence with an angle to the left of 74°00', a distance of 290 feet; thence with an angle to the right of 59°00', a distance of 150 feet; thence with an angle to the right of 30°00', a distance of 150 feet; thence with an angle to the right of 75°00', a distance of 400 feet; thence with an angle to the left of 66°00', a distance of 415 feet, more or less, to the South line of a tract, as recorded in Deed Book 1230, Page 91; thence East along said South line 170 feet, more or less, to the Westerly right-of-way line of said Railroad; thence Southerly along said railroad right-of-way, a distance of 974 feet, more or less, to a point 824.45 feet North of the South line of said Section 13; thence West a distance of 70 feet, more or less, to the place of beginning.
