

**AMENDMENT # 1**

This amendment is made and entered into this 1st day of July, 2011 by and between Sedgwick County Developmental Disability Organization, whose address is 615 N. Main, Wichita, KS 67203, hereinafter referred to as "CDDO" (Community Developmental Disabilities Organization) and the Secretary of the Kansas Department of Social and Rehabilitation Services, whose address is 915 SW Harrison, Docking State Office Building, Topeka, Kansas 66612, hereinafter referred to as "SRS".

WHEREAS, Contractor and SRS have executed an Agreement dated July 1, 2010 providing for certain goods and services; and

WHEREAS, CDDO and SRS are desirous of executing this Amendment.


NOW, THEREFORE, for and in consideration of the mutual covenants and agreements contained herein, Contractor and SRS do hereby mutually covenant and agree as follows:

- 1) The above referenced Agreement and any subsequent addenda shall be amended as follows:
  - a. **BASIC CONTRACT INFORMATION**  
Contract Period: July 1, 2010 through June 30, 2011 shall be extended to September 30, 2011.
  - b. Addendum 2 Total Allocation Award and Reimbursement Source as attached to Amendment 1.
- 2) All other terms and conditions of said Agreement and subsequent addenda shall remain the same.


