

ORDINANCE NO. 1095-05

AN ORDINANCE ANNEXING LAND TO THE CITY OF VALLEY CENTER, KANSAS (adjacent to the Miles Addition to the City).

WHEREAS, the following described land is located in Sedgwick County, Kansas; and

WHEREAS, the following described land meets one or more of the conditions prescribed by K.S.A. 12-520(a)(1)-(6); and

WHEREAS, the governing body of the City of Valley Center, Kansas, finds it advisable to annex such land.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF VALLEY CENTER, KANSAS:

Section 1. That the following described land, meeting the conditions for annexation prescribed in K.S.A. 12-520, is hereby annexed and made a part of the City of Valley Center, Kansas:

Tract 1: GT 00211000K

Beginning at the Northeast corner of Lot 1 Miles 2nd Addition; thence East to the east line of the Southwest quarter of Section 31, Township 25 South, Range 1 East of the Sixth Principal Meridian, Sedgwick County, Kansas; thence South to the south line of Lot 1 extension; thence Northwesterly to the southeast corner of Lot 1; thence North to the beginning, except the East 75 feet.

Tract 2: GT 00211

Beginning at the Northeast corner of Lot 2 Miles 2nd Addition; thence Southwesterly to the southeast corner of Lot 2; thence Southeasterly along the extension of the South line of Lot 2 to the East line of the Southwest quarter of Section 31, Township 25 South, Range 1 East of the Sixth Principal Meridian, Sedgwick County, Kansas; thence North to a point easterly of the beginning westerly line along the extension of the North line of Lot 2 to the beginning, except the East 75 feet.

Tract 3: GT 00211000J

Beginning at the Northeast corner of Lot 3 Miles 2nd Addition; thence Easterly to the east line of the Southwest quarter of Section 31, Township 25 South, Range 1 East of the Sixth Principal Meridian, Sedgwick County, Kansas; thence South to the south line of Lot 3 extension; thence Northwesterly to the southeast corner of Lot 3; thence Northeasterly to the beginning, except the East 75 feet.

Section 2. That this ordinance shall be effective from and after its passage, approval, and publication in the official city newspaper.
