

FIRST AMENDMENT TO THE CHARITABLE DONATION AGREEMENT

**BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS

SEDGWICK COUNTY FIRE DISTRICT NUMBER ONE
and
THE PAULINE M. WEBER TRUST**

This First Amendment to the Charitable Donation Agreement ("First Amendment") is made and entered into this ____ day of _____, 2018, by and between the Board of County Commissioners of Sedgwick County, Kansas, sitting as the governing body of Sedgwick County Fire District Number One, a fire district located within Kansas ("Fire District"), and the Pauline M. Weber Trust ("Owner").

WITNESSETH:

WHEREAS, Owner formerly owned a residence in the unincorporated area of Sedgwick County, Kansas, located at 14010 W. 29th Street North, Wichita, Kansas ("Residence"), which was donated to the Fire District pursuant to a Charitable Donation Agreement ("Original Agreement"), entered into on May 17, 2017; and

WHEREAS, the term of the Original Agreement indicated that the Live Fire Training Event (the conclusion of the Original Agreement during which the Residence was to be burned down) would be completed by June 1, 2018; and

WHEREAS, the parties would like to extend the term of the Original Agreement as indicated in this First Amendment; and

WHEREAS, Paragraph 20 of the Original Agreement indicates that it may be amended if the parties agree to such amendment in writing and the parties wish to indicate their consent to such an amendment.

NOW, THEREFORE, in consideration of the mutual covenants, conditions and promises contained herein, the parties hereto agree as follows:

1. Amendment to Paragraph 2 of the Original Agreement. It is agreed between the parties that the Paragraph 2 of the Original Agreement is modified to indicate that the Live Fire Training Event will conclude by 11:59 P.M. on November 1, 2018.

2. Other Terms and Conditions in the Original Agreement. The parties agree that, apart from terms specifically identified in Paragraph 1 of this First Amendment, all other terms and conditions of the Original Agreement remain unchanged.




