**RESOLUTION DESIGNATING AND CLASSIFYING CERTAIN ROADS UNDER K.S.A. 68-506**

WHEREAS, Sedgwick County is a non-unit road system county, operating under the provisions of K.S.A. 68-506, et seq.; and,

WHEREAS, public roads have been constructed in the Spring Acres Addition subdivision; said roads being 329<sup>th</sup> Street West, 331<sup>st</sup> Street West, and 20<sup>th</sup> Street North; and,

WHEREAS, said construction has been performed in accordance with County regulations and has been approved by the County Engineer; and,

WHEREAS, said roads are neither a secondary road nor county minor collector road and therefore should be designated and classified as a Grand River Township roads; and,

WHEREAS, the County Engineer has approved such designation and classification.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that upon the recommendation of the County Engineer the following roads be and are hereby designated and classified as township roads:

331<sup>st</sup> Street West  
20<sup>th</sup> Street North

the same being located in the northeast ¼ of Section 11, T29S, R4W, Sedgwick County, Kansas.


