**A RESOLUTION APPOINTING MICAH SCOGGAN TO THE SEDGWICK COUNTY
STORMWATER MANAGEMENT ADVISORY BOARD IN THE
CITY OF GODDARD'S POSITION**

WHEREAS, the Sedgwick County Stormwater Management Advisory Board (“SMAB”) was established pursuant to Sedgwick County Resolution No. 242-2007; and was subsequently repealed and replaced by Sedgwick County Resolution No. 188-2012; and

WHEREAS, each of the five (5) Sedgwick County Commissioners appoints one member to SMAB, which members serve at the pleasure of the appointing commissioner; and the Board of County Commissioners as a whole appoints thirteen (13) additional positions that have been nominated by a municipality or active watershed district or drainage district that agrees to comply with the responsibilities as contained in Sedgwick County Resolution No. 188-2012; and

WHEREAS, ten (10) cities in Sedgwick County, which includes the City of Goddard, as well as three (3) watershed districts nominate representatives to the Sedgwick County Commission for appointment to the Board; and

WHEREAS, Tim Johnson, the City of Goddard’s representative, has discontinued his employment with the City of Goddard and the City has nominated Micah Scoggan as a replacement for this position; and

WHEREAS, it is the desire of the Board of County Commissioners to appoint Micah Scoggan as the City of Goddard’s representative to the Sedgwick County Stormwater Management Advisory Board (“SMAB”), effective January 23, 2019.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS that:

Micah Scoggan is hereby appointed to the Sedgwick County Stormwater Management Advisory Board and shall serve at the pleasure of the City of Goddard.
