**A RESOLUTION APPOINTING ROBERT BAKER TO THE  
SEDGWICK COUNTY ADVISORY COUNCIL ON AGING**

WHEREAS, Sec. 2-161 of the *Sedgwick County Code* provides for the establishment of the Sedgwick County Advisory Council on Aging, and Sec. 2-162 thereof provides for the appointment by the Board of County Commissioners of members thereto and their term of membership; and

WHEREAS, a vacancy has been created due to the January 2016 resignation of Ms. Andréé Sisco, one of Commissioner James Howell's appointees; and

WHEREAS, it is the recommendation of Commissioner Howell that Robert Baker be appointed to the Sedgwick County Advisory Council on Aging for District Five, to fill the balance of Ms. Sisco's unexpired term.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that Robert Baker is hereby appointed to the Sedgwick County Advisory Council on Aging, effective February 3, 2016. The term of this appointment shall expire March 17, 2019, except that in the event the Commissioner making the recommendation for the appointment herein leaves office for any reason, the said term shall expire and the member shall then serve until a successor has been duly appointed.


