On the recommendation of Joe Thomas, on behalf of Public Works, David Spears moved to accept the bid from Wichita Concrete Pipe Company and establish contract pricing at the rates listed above for a period of one (1) year with two (2) one (1) year options to renew. Sara Jantz seconded the motion. The motion passed unanimously.

Pre-cast reinforced concrete boxes and end sections are drainage structures, and they are often referred to as RCBs or box culverts. They are typically larger than round pipe and used when a round pipe will not provide adequate flow capacity. They are fabricated off-site in a precast manufacturing facility and delivered to the work site ready for installation.

Each precast unit is typically fabricated in 6' cells, and they are put together in the field to make whatever length is required.

Several vendors chose not to provide a bid since they are located outside of the Wichita metro area and their freight costs would render their quotes non-competitive.

On the recommendation of Brandy McCune, on behalf of COMCARE, Linda Kizzire moved to **accept the quote from Association of Community Mental Health Centers of Kansas, Inc. for \$35,863.86**. Jennifer Dombaugh seconded the motion. The motion passed unanimously.

The association represents the entire system of mental health care for the State of Kansas and provides the State a single point of contact for the mental health care agencies. They also provide education, networking and education to the legislature on a wide array of behavioral health issues. Due to their efforts, \$15.2 million in proposed statewide CMHC cuts did not happen. COMCARE's share of that would have been approximately \$2 million. Without the support and help of the association during the legislative session, COMCARE staff would end up in Topeka during the entire session which would reduce resources in the local community during this time.

This item was previously approved by Bid Board on June 9, 2011, but the item was pulled before going to BOCC for further review by the Manager; Manager is ready to proceed.
