

RESOLUTION

**A RESOLUTION APPOINTING MEMBERS TO THE SEDGWICK COUNTY AND
CITY OF WICHITA JOINT BOARD OF ELECTRICAL APPEALS**

WHEREAS, the Board of County Commissioners adopted Resolution No. 135-2012 on August 29, 2012 and the City of Wichita adopted City Ordinance No. 49-333 on August 21, 2012, agreeing to consolidate the Board of Electrical Appeals (“Joint Board”); and

WHEREAS, the Board of County Commissioners adopted the Unified Code on November 21, 2012, and the City of Wichita adopted the Unified Code on December 4, 2012; and

WHEREAS, Article 1, Section 5 of the Unified Code provides for the terms of appointments to said Joint Board; and

WHEREAS, Article 4, Section A of the Unified Code authorizes said Joint Board and the qualifications for members of same.

WHEREAS, it is the desire of the Board of County Commissioners that the following members be appointed to the Joint Board and that the terms of said members shall be two years from the date of appointment.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that the following individuals are hereby appointed as Sedgwick County’s appointments to the Joint Board:

County Appointment:	Journeyman Electrician	Earnest E. Nelson
County Appointment:	Electrical Engineer	John Murrell

The term of the appointments herein shall be two years from the date of appointment, or until a successor has been appointed, qualified and sworn to the oath of office before the County Clerk.

BE IT FURTHER RESOLVED that the members appointed herein shall subscribe to the oath of office prior to assuming duties as a member of said Joint Board.
