

On or about October 18, 2006, the City of Derby annexed an area of land that included the property currently owned by you. The Sedgwick County Commission is required to hold a public hearing five years following the annexation of property to determine whether the city has provided services set out in the timetable in the service plan prepared at the time of annexation.
