

# RESOLUTION

## A RESOLUTION AUTHORIZING SALE OF UNREDEEMED REAL ESTATE AFTER TAX SALE

**WHEREAS**, pursuant to K.S.A. §79-2801, as amended, the Board of County Commissioners of any county is required to file foreclosure proceedings in court to recover the unpaid amounts; and

**WHEREAS**, numerous parcels of real estate have been sold and bid in, in the name of Sedgwick County, Kansas at the delinquent tax sale in October 2013, and prior years, and remain unredeemed on the 1st day of September of the second year or more after such sales; and

**WHEREAS**, K.S.A. §79-2801 requires counties to foreclosure unpaid real estate taxes whenever the aggregate assessed valuation of the real estate subject to sale is \$300,000 or more, or the aggregate amount of delinquent taxes, including special assessments is \$10,000 or more.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:**

**SECTION I.** A judicial foreclosure and sale of all real estate tax liens be held and the County Counselor of Sedgwick County is hereby ordered to have the necessary petition prepared in order to have a tax sale of all real estate which has been sold to the county for taxes and which remains unredeemed as of at least two years or more after such sale pursuant to K.S.A. §79-2801, as amended, and all prior filings and actions in this regard are approved and ratified.

**SECTION II.** The County Counselor of Sedgwick County has been and is authorized and empowered to enter into a contract with bonded and licensed abstractors to obtain abstracting services and to hire such outside counsel as is reasonably necessary to secure the timely performance of this order, and all prior actions in this regard are approved and ratified.
