A RESOLUTION MODIFYING CHAPTER 5 OF THE *SEDGWICK COUNTY CODE* PERTAINING TO ANIMALS BY RESCINDING SEDGWICK COUNTY RESOLUTION NO. 51-2014, REESTABLISHING THE ANIMAL CARE ADVISORY BOARD, AND ADDING TANGANYIKA WILDLIFE PARK AS A LOCATION PERMITTED TO HARBOR INHERENTLY DANGEROUS ANIMALS.

WHEREAS, pursuant to K.S.A. 19-101d, the Kansas State Legislature granted the Board of County Commissioners of Sedgwick County the authority to enforce all resolutions passed pursuant to county home rule powers; and

WHEREAS, on February 4, 1987 and December 2, 1992, the Board of County Commissioners adopted Resolution Nos. 17-1987 and 270-1992, respectively, and said resolutions provided the majority of the content contained within Chapter 5 of the *Sedgwick County Code* pertaining to Animals, as of April 16, 2014; and

WHEREAS, subsequent modifications to provisions of Chapter 5 of the *Sedgwick County Code* have occurred and are presently part of Chapter 5, including but not limited to Resolution Nos. 22-1996, 29-1996, 35-00, 189-2001, 142-2002, 63-03, and 15-2007; and

WHEREAS, on April 16, 2014, the Board of County Commissioners adopted Resolution No. 51-2014, which further modified Chapter 5 of the *Sedgwick County Code* and established the Animal Control Advisory Board in place of the Animal Care Advisory Board.

NOW, THEREFORE, BE IT RESOLVED THAT THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, AMENDS THE *SEDGWICK COUNTY CODE* AS FOLLOWS:

SECTION 1. SEDGWICK COUNTY RESOLUTION NO. 51-2014 IS RESCINDED.

Sedgwick County Resolution No. 51-2014 is hereby rescinded. Any provisions of Chapter 5 of the *Sedgwick County Code* that were modified or repealed as a result of Sedgwick County Resolution No. 51-2014 are reinstated in full effect as they existed prior to the adoption of said resolution.

SECTION 2. DISSOLUTION OF THE ANIMAL CONTROL ADVISORY BOARD AND REESTABLISHMENT OF THE ANIMAL CARE ADVISORY BOARD.

The Animal Control Advisory Board is hereby dissolved. The Animal Care Advisory Board is hereby reestablished in place of the Animal Control Advisory Board, and shall exist in accordance with Sections 5-51 through 5-55 of Sedgwick County Resolution No. 17-1987.

SECTION 3. ADDITIONAL EXCEPTION TO PROHIBITION AGAINST HARBORING INHERENTLY DANGEROUS ANIMALS.

Section 5-227. Exceptions to Prohibition, is hereby amended to add the following subsection:

(10) Tanganyika Wildlife Park.

SECTION 4. PUBLICATION.

Upon the adoption of this Resolution, the Clerk of Sedgwick County shall publish this Resolution once in the official County newspaper. This Resolution shall take effect upon said publication.


