**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, APPOINTING RICHARD RANZAU AS REPRESENTATIVE TO THE GOVERNING BODY OF THE REGIONAL ECONOMIC AREA PARTNERSHIP (REAP), AND APPOINTING DAVID M. UNRUH AS AN ALTERNATE MEMBER TO THE GOVERNING BODY OF REAP**

WHEREAS, on October 13, 1999, Sedgwick County, Kansas became a member of the Regional Economic Area Partnership (REAP); and

WHEREAS, the bylaws of REAP provide that each member in good standing shall be entitled to designate one voting member and one alternate member who will be allowed to vote in the absence of said voting member, to sit on the REAP Board; and

WHEREAS, the bylaws of REAP further provide that voting members of REAP shall be an elected official of the respective city or a county commissioner. Alternate members may be either an elected official or appointed official from the member government; and

WHEREAS, it is the desire of the Board of County Commissioners to appoint Richard Ranzau, Commissioner, Fourth District, as its designee to serve as the County representative on the governing body of REAP, and to appoint David M. Unruh, Commissioner, First District, as an alternate member to represent the County.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that

1. Richard Ranzau is hereby appointed to serve as Sedgwick County's representative to the governing body of REAP.
2. David M. Unruh is hereby appointed to serve as Sedgwick County's alternate representative to the governing body of REAP.
3. These representatives shall serve at the pleasure of the Board of County Commissioners of Sedgwick County, Kansas.
