#### SUBJECT: AMENDED AGREEMENT WITH THE NATIONAL ASSOCIATION OF COUNTIES (NACo)

The NACo and CVS prescription, health, and dental discount program provides Sedgwick County residents with access to prescription, health and dental discounts for savings on treatments, procedures, and supplies. The prescription discount program is free to residents. The health and dental discount programs are fee-based programs and residents can pay either a monthly or annual fee to obtain discounts and savings.

The Health Department Community Health Navigators (CHN) Program is a group of volunteers who distribute health education materials and affordable healthcare access materials to Sedgwick County residents. Community Health Navigators reach residents in the community at the neighborhood, church, and other civic organization levels. Data collected in 2014 identified 207 NACo card distribution site locations in the community and 3,981 Sedgwick County residents utilized the discount cards.

On January 21st, at the request of several commissioners, staff prepared an analysis of two dental discount plans: Careington's My County Cares and the CVS CAREMARK plan offered to NACo members. Upon further discussion with commissioners, staff included a review of the "One Card" option offered by Careington that includes dental, health, and pharmacy discounts.

#### Key differences between the plans include:

Careington My County Cares Dental Plan

- Offers 49 dental providers
- Cost and discount rates are similar to CVS CAREMARK plan
- Requires a one-time registration \$10 fee

#### NACO and CVS Dental Plan

- Offers 89 dental providers
- Costs and discount rates are similar to Careington My County Cares Dental Plan
- No registration costs

#### Careington One Card

- Least expensive option at \$89.00 Individual / \$99.00 Family
- Offers 90 Pharmacies
- Offers 49 dental providers
- Requires a one-time registration \$10 fee

Alternatives: Staff has prepared three options for consideration:

- 1) Approve staff's recommendation action from January 21st and enter into an amended agreement with NACo to add discount dental service to the Prescription/Health discount card.
- 2) Reject staff's recommended action and enter into an agreement with Careington for dental service and continue to contract with NACo and CVS CARDMARK for the Prescription/Health discount cards.
- 3) Terminate the contract with NACo and CVS CAREMARK and enter into an agreement with Careington for the "One Card" program.

### **Option 1: Approve agreement with NACo and CVS CAREMARK**

**Analysis:** The NACo and CVS Careington dental discount card allows participants to receive discounts on dental services throughout the county. The card is accepted by dental 89 providers in Sedgwick County. Below is an overview of the dental discount card:

# **Option 2: Continue NACo and CVS CAREMARK Health and Prescription plan and enter into a contract with Careington for Dental Services**

Analysis: This option provides a hybrid model of the two services. This option allows the county to continue using the services from NACo and CVS CAREMARK that are already in existence and will not result in a disruption of services for citizens currently using the NACo CVS CAREMARK Prescription/Health discount plan. Additionally, the county is currently under contract with NACo and CVS CAREMARK until April of 2015 for the Prescription/Health discount cards. Below is an overview of the membership costs and discounted rates under this model:

## Option 3: Terminate the contract with NACo and CVS CAREMARK and enter into an agreement with Careington "One Card".

**Analysis:** Under this option the county would terminate the contract with NACo CVS CAREMARK for Prescription/Health discount cards and instead enter into an agreement with Careington for their "One Card Service" for dental, pharmacy, and other discounts. The current contract with NACo will automatically renew in April of 2015. A notice of termination must be submitted 60 days prior to the contract termination date. The One Card plan offered through Careington is the lowest cost option. However, terminating the contract with NACo and CVS CAREMARK will result in participants losing access to the Prescription/Health discounted savings from the NACo and CVS CAREMARK card and the card holders will be required to apply for the Careington One Card. Below is an overview of the membership costs and discounted rates under this model:
