RESOLUTION AND ORDER

BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS:

THERE MET in regular session this 30th day of March, 1963, in their office in the Courthouse in Wichita, Kansas, the Board of County Commissioners of Sedgwick County, Kansas. Commissioners present as follows:

THEREUPON, the Commissioners having investigated and being duly advised in the premises by Donald C. Campbell, the immediate past Trustee for the Township Board of Wichita Township, Sedgwick County, Kansas, and having reviewed the annexation proceedings of the City of Wichita, find that the number of electors in said township are fewer than ten (10) and that it is the duty of the County Commissioners to disorganize said township as provided in G. S. 1949, 80-1101, 80-1102.

THEREUPON, Motion being duly made and seconded, the following resolutions and orders were by unanimous vote made and adopted:

"BE IT RESOLVED, That Wichita Township, Sedgwick County, Kansas, be and the same is hereby disorganized."

"BE IT FURTHER RESOLVED that the following described area, towit:

Beginning at the N.E. Corner of Section 1, Township 27 South, Range 1 East of the 6th P.M.; thence South along the east line of said Section 1 to the north line of Third Addition to Cresview Heights, extended from the west; thence west along the north line of said Addition to the west line of said Addition; thence south along the west line of said Addition to the north line of 21st Street; thence west along the north line of 21st Street to the east line of the Southwest Quarter of Section 1, Township 27 South, Range 1 East of the 6th P.M.; thence north along said east line to the north line of said Southwest Quarter; thence west along said north line to the east line of Oliver Avenue; thence north along said east line of Oliver Avenue to the south line of the Southwest Quarter of Section 36, Township 26 South, Range 1 East of the 6th P.M.; thence east along said south line to the point of beginning.

be and the same is hereby attached to and made a part of Kechi Township, Sedgwick County, Kansas."

"BE IT FURTHER RESOLVED, that the following described area, towit:

W/I 12
Beginning at the N. E. Corner of the N. W. Quarter Section 2, Township 27 South, Range 1 East of the 6th P.M.; thence South along the East line of the N.W. Quarter of Section 2 to the North line of Charron's Garden Addition as extended from the West; thence West along the North line of Charron's Garden Addition as extended and the North line of Charron's Garden Addition to the East line of Hillside Avenue; thence North along said East line to the North line of the N.W. Quarter, Section 2, Township 27 South, Range 1 East of the 6th P.M.; thence East along the North line of Section 2 to the place of beginning.

Quarter of said Section 36; thence North to the Northerly right-of-way line of the Kansas Turnpike; thence Northeasterly along said right-of-way to the East line of said S. E. Quarter of Section 36, Township 27 South, Range 1 East of the 6th P.M.; thence South along said east line of S.E. Quarter, Section 36, to the point of beginning.

E. Quarter of Section 24, Township 27 South, Range 1 East of the 6th P.M.; thence East to the point of beginning.

"BE IT FURTHER RESOLVED AND ORDERED that the Township Officers of Wichita Township be and they are hereby directed to turn over to the Board of County Commissioners of Sedgwick County, Kansas, all property, books, records, funds and equipment belonging to said Wichita Township, pursuant to G. S. 1949, 80-1104."
