**AGREEMENT FOR MAINTENANCE
OF TOWNSHIP ROADS**

THIS AGREEMENT is made and entered into this 4th day of June, 2012, by and between the Minneha Township Board of Highway Commissioners of Sedgwick County, Kansas, hereinafter referred to as "Minneha" and the City of Eastborough, hereinafter referred to as "Eastborough."

WITNESSETH:

WHEREAS, Eastborough is a City of the Third Class within Minneha Township, Sedgwick County, Kansas; and

WHEREAS, Minneha and Eastborough are each authorized to enter into an agreement for road maintenance pursuant to K.S.A. 68-572.

NOW, THEREFORE, in consideration of the parties' mutual promises and covenants, it is agreed as follows:

1. The parties agree that Minneha will provide street sweeping maintenance of all of the streets of Eastborough every three (3) months without charge.
2. The term of this agreement shall be annually from July 1 to June 30 of each year and shall automatically renew for successive years unless notice of cancellation is given by registered mail by either party at least 30 days prior to the renewal date. Minneha will furnish Eastborough a certificate of insurance in the amount of one million dollars.



- 1.) Frequency of Service – January, April, July & October
- 2.) ALL Interior streets are to be swept.
- 3.) Exterior Streets
 - A.) Woodlawn – East Lane only from Kellogg north to Douglas. The City of Wichita is responsible for the West lane.
 - B.) Woodlawn from Douglas to Second Street – sweep both east and west lanes.
 - C.) Douglas to Norfolk – North Lane only – South lane is City of Wichita.
