CorVel Healthcare Corporation provides auditing, review and repricing services of all workers' compensation medical bills to a fee schedule which is mandated by the Kansas Workers' Compensation statutes. They also provide access to their PPO network and to their internet software program.

The County spent \$25,754.00 in 2013 and \$14,994.00 in 2014 for these services.

\* Note: AWP stands for average wholesale pricing. The pricing submitted by CorVel Healthcare Corporation is lower than the Kansas fee schedule (which is less 15% + \$5.00 for generic drugs and less 10% + \$3.00 for brand name drugs).
