A RESOLUTION AMENDING THE EXHIBIT TO RESOLUTION 189-2013 PROVIDING FOR THE APPLICABILITY OF THE KANSAS PERSONAL AND FAMILY PROTECTION ACT TO COUNTY-OWNED AND COUNTY-LEASED PROPERTY

WHEREAS, the Board of County Commissioners of Sedgwick County, Kansas, previously adopted Resolution No. 189-2013, which included an exhibit listing various categories of County-owned and County-leased buildings and the status on whether concealed carry of handguns were permitted or prohibited; and

WHEREAS, the first four pages of the exhibit listed buildings that are eligible for posting as against concealed carry either because the buildings have adequate security measures or are locations that are secure in whole or in part, and are either jail, corrections or law enforcement facilities; and

WHEREAS, the fifth page of the exhibit listed buildings leased by the County as tenant where the landlord controlled the posting of signs prohibiting concealed carry at the time Resolution No. 189-2013 was adopted; and

WHEREAS, the exhibit on the sixth page listed County buildings that are leased by the County as landlord to a private entity, either for profit or non-profit, and the exhibit noted that the tenants in those buildings maintained the right to prohibit concealed carry in accordance with the Personal and Family Protection Act, K.S.A. 75-7c01, et seq. (the Act); and

WHEREAS, the Act generally restricts the prohibition of concealed carry in municipal buildings, but the Act excludes from the definition of the term "municipal building" any "building owned by the state or a municipality which is leased by a private entity whether for profit or not-for-profit"; and

WHEREAS, circumstances regarding certain buildings listed on the fifth page of the exhibit have changed; and

WHEREAS, the buildings listed on the sixth page of the exhibit are not considered municipal buildings for the purposes of the Act; and

WHEREAS, the status of concealed carry in the buildings listed on the sixth page remain a matter between the landlord and tenant governed by the applicable lease provisions; and

WHEREAS, Sedgwick County supports concealed carry in as many local government facilities as possible;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS THAT:

Page 5 of Exhibit A to Res. No. 189-2013 is modified as follows:

#3 - Comcare Children's Services Equity Bank Building - no longer leased by County

#4 – Environmental Resources 2625 S. Tyler Rd. – no longer posted against concealed carry

#6 – Health Department Administration 1900 E. 9th St. – no longer posted against concealed carry

These buildings are deleted from the list of buildings on the fifth page of the exhibit.

Page 6 of Exhibit A to Res. No. 189-2013 is deleted from the resolution. The remainder of Res. No. 189-2013 remains in effect. This resolution shall take effect upon its adoption. Commissioners present and voting were:
