#### RESOLUTION NO. \_\_\_\_-2015

A RESOLUTION AMENDING AND SUPPLEMENTING RESOLUTION NO. 165-2014 OF SEDGWICK COUNTY, KANSAS, WHICH DETERMINED THE ADVISABILITY OF AND AUTHORIZED THE CREATION OF A BENEFIT DISTRICT IN SEDGWICK COUNTY, KANSAS; MADE CERTAIN FINDINGS RELATING THERETO; AND AUTHORIZED AND PROVIDED FOR THE MAKING OF CERTAIN ROAD IMPROVEMENTS THEREIN (CESSNA ADDITION).

**WHEREAS**, the Board of County Commissioners (the "Board") of Sedgwick County, Kansas (the "County"), has heretofore by Resolution No. 165-2014 of the County, duly adopted on December 17, 2014 (the "Prior Resolution"), created the Cessna Addition improvement benefit district (the "District") and authorized, pursuant to K.S.A. 68-728 *et seq.*, as amended by Charter Resolution No. 61 (the "Charter Resolution" and collectively, the "Act"), the following described road improvements:

Construction of street and drainage improvements, consisting of widening Ridge Road (71st Street West) for 725 lineal feet beginning approximately 600 feet south of Kansas Highway 42 centerline, and regrading the existing east roadside ditch, all to serve the Benefit District, to be constructed in accordance with the plans and specifications of Sedgwick County Public Works; and

**WHEREAS**, the Prior Resolution was recorded with the Register of Deeds of Sedgwick County, Kansas, and appears at DOC.#/FLM-PG: 29497667; and

WHEREAS, the County has received an updated Petition proposing a modification of the estimated costs of the Improvements; and

**WHEREAS**, the Board of the County hereby finds and determines that said updated Petition is sufficient and that it necessary to make such modifications; and

WHEREAS, in order to make such modifications, the Board of the County hereby finds and determines it necessary to amend and supplement *Section 1* of the Prior Resolution, as hereinafter set forth.

# THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS:

**SECTION 1.** Amendment. SECTION 1 of the Prior Resolution is hereby amended and supplemented to read as follows:

**SECTION 1.** Creation of Benefit District; Authorization of Improvements. The Board, after due consideration of the factors set forth in the Act, hereby finds and determines that: (a) It is advisable to create a benefit district (the "Benefit District") hereinafter described and make the road improvements hereinafter described (the "Improvements");

(b) The real property to be included within the Benefit District, to be assessed for the cost of the Improvements as follows:

Lot 1, Block 1, Cessna Addition to Sedgwick County, Kansas.

(c) The general nature of the Improvements is as follows:

Construction of street and drainage improvements, consisting of widening Ridge Road (71st Street West) for 725 lineal feet beginning approximately 600 feet south of Kansas Highway 42 centerline, and regrading the existing east roadside ditch, all to serve the Benefit District, to be constructed in accordance with the plans and specifications of Sedgwick County Public Works.

(d) The estimated or probable costs of the Improvements are: \$196,000, to be increased at the pro rata rate of one percent (1%) per month from and after adoption of this Resolution.

(e) The method of assessment is equally per square foot. In the event that such parcel is subdivided, the assessment on that parcel shall be prorated to the new parcels on the basis of land area.

(f) The apportionment of the costs of the Improvements between the Benefit District and the County-at-large is: One Hundred percent (100%) to be assessed against the Benefit District and Zero percent (-0-%) to be paid by the County-at-large.

It is acknowledged that the Benefit District does not include all properties which may be deemed to benefit from the Improvements.

**SECTION 2.** Repealer; Ratification. Section 1 of the Prior Resolution is hereby repealed; and the rest and remainder thereof is hereby ratified and confirmed.

**SECTION 3. Effective Date.** This Resolution shall be effective upon adoption. This Resolution shall be published one time in the official County newspaper, shall be filed of record in the Office of the Register of Deeds of the County.
