

ORDINANCE NO. 813

AN ORDINANCE OF THE CITY OF MAIZE, KANSAS (THE CITY), ANNEXING LAND TO THE CITY.

WHEREAS, the herein described land is located in Sedgwick County, Kansas;

WHEREAS, the City heretofore adopted an annexation resolution that was mailed to affected landowners by certified mail and was published in the official City newspaper;

WHEREAS, pursuant to notice contained in the annexation resolution, a public hearing was duly held regarding the consideration of the annexation of the herein-described real property;

WHEREAS, the herein described real property meets one or more of the conditions prescribed by K.S.A. 12-520(a)(1) - (6); and

WHEREAS, the governing body of the City, after otherwise complying with statutory requirements relating to the unilateral annexation of real property pursuant to K.S.A. 12-519 *et seq.*, finds it advisable to annex the herein described land.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MAIZE, KANSAS:

Section 1. The herein described land, meeting the conditions of annexation prescribed in K.S.A. 1999 Supp. 12-520, is hereby annexed and made a part of the City, to wit:

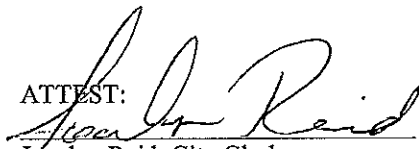

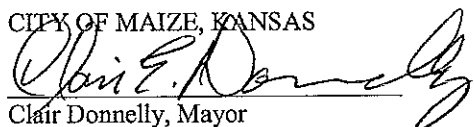
Section 2. This ordinance shall be effective from and after its passage, approval and publication in the official City newspaper.
