**A RESOLUTION REAPPOINTING DAVE JONES TO THE SEDGWICK COUNTY

The term of this appointment shall expire June 16, 2019, except that in the event the Commissioner making the recommendation for the appointment herein leaves office for any reason, the said term shall expire and the member shall then serve until a successor has been duly appointed.


