**A RESOLUTION APPOINTING AND REAPPOINTING MEMBERS TO THE  
SEDGWICK COUNTY AND CITY OF WICHITA JOINT BOARD OF APPEALS OF  
PLUMBERS AND GAS FITTERS**

WHEREAS, the Board of County Commissioners adopted Resolution No. 135-2012 on August 29, 2012 and the City of Wichita adopted City Ordinance No. 49-333 on August 21, 2012, agreeing to consolidate the Board of Appeals of Plumbers and Gas Fitters ("Joint Board"); and

WHEREAS, the Board of County Commissioners adopted the Unified Code on November 21, 2012, and the City of Wichita adopted the Unified Code on December 4, 2012; and

WHEREAS, Article 1, Section 5 of the Unified Code provides for the terms of appointments to said Joint Board; and

WHEREAS, Article 3, Section A of the Unified Code authorizes said Joint Board and the qualifications for members of same.

WHEREAS, it is the desire of the Board of County Commissioners that the following members be reappointed and newly appointed to the Joint Board and that the terms of said members shall be two years from the effective date of appointment.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that the following individual is hereby reappointed as Sedgwick County's appointment to the Joint Board:


