THE CITY OF GODDARD, KANSAS **ORDINANCE NO. 729** AN ORDINANCE ANNEXING AND INCORPORATING CERTAIN LAND WITHIN THE BOUNDARIES OF THE CITY OF GODDARD, KANSAS.

WHEREAS, in Ordinance No., 707, adopted by the City of Goddard on October 4th, 2010, THE City granted the Annexation of certain land; and
