**A RESOLUTION AMENDING RESOLUTION 88-2015**

WHEREAS, pursuant to Sedgwick County Personnel Policy and Procedures Manual, Section 4.502, paragraph III (I), the Grievance Hearing Board shall consist of three members appointed by and serving at the pleasure of the Board of County Commissioners for a term of two years; and

WHEREAS, such appointees shall include one classified Sedgwick County employee, one department head, and one elected official of Sedgwick County who shall serve as chair; and

WHEREAS, three alternate members shall be appointed in the same manner; and

WHEREAS, on May 6, 2015, Kelly B. Arnold was reappointed to the Grievance Hearing Board as the Elected Official, Scott Hadley, was reappointed to the Grievance Hearing Board as the Alternate Department Head, and Richard Vargas, was appointed to the Grievance Hearing Board as the Alternate Classified Employee, all to serve two year terms expiring on April 7, 2017; and

WHEREAS, the date of expiration of April 7, 2017 is incorrect; and

WHEREAS, the date of expiration should have been listed as May 5, 2017; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS that the term of Kelly B. Arnold reappointed to the Grievance Hearing Board as the Elected Official, Scott Hadley, reappointed to the Grievance Hearing Board as the Alternate Department Head, and Richard Vargas, appointed to the Grievance Hearing Board as the Alternate Classified Employee, shall all serve two year terms expiring on May 5, 2017, or at the pleasure of the Board of County Commissioners.
