## **ORDINANCE NO. 2257**

AN ORDINANCE APPROVING AND AUTHORIZING AN AGREEMENT FOR ENHANCED AUTOMATIC AID RESPONSE BETWEEN THE CITY OF DERBY, KANSAS AND THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, AS THE GOVERNING BODY OF SEDGWICK COUNTY FIRE DISTRICT **ACCORDANCE** WITH ONE. IN NUMBER PROVISIONS OF K.S.A. 19-3608

WHEREAS, K.S.A. 19-3608 authorizes fire districts to contract with a city having an organized fire department in its county for fire protection services and for the use, operation, care and maintenance of any fire apparatus or equipment belonging to such district by said city upon the passage of a resolution by the County and an ordinance by the city authorizing the same; and

WHEREAS, the Board of County Commissioners of Sedgwick County, Kansas, as the governing body of Sedgwick County Fire District Number One (hereinafter referred to as the "District"), and the City of Derby, Sedgwick County, Kansas (hereinafter referred to as the "City") have previously entered into an Mutual Aid Agreement and an Automatic Aid Agreement for structure fires for the provision of fire protection services within both jurisdictions by both entities;

WHEREAS, the Board of County Commissioners of Sedgwick County, Kansas, as the governing body of the District, and the City desire to enter into a contract for the purpose of establishing an Enhanced Automatic Aid Response System to regulate certain operations involving both the City and the District.

## NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF DERBY, KANSAS:

## Section 1. Authorization

In accordance with the provisions of K.S.A. 19-3608, the governing body of the City of Derby, Kansas hereby approves and authorizes the City to enter into and the Mayor to execute an Agreement for Enhanced Automatic Aid Response with the Board of County Commissioners of Sedgwick County, Kansas, as the governing body of the District, for the purpose of establishing an Enhanced Automatic Aid Response System to regulate certain operations involving both the City and the District.

## **Effective Date** Section 2.

This Ordinance shall take effect and be in force from and after its passage and publication of the ordinance or a summary thereof once in the City's official newspaper as provided by State law.
