**A RESOLUTION APPOINTING COMMISSIONER JAMES M. HOWELL TO THE  
SEDGWICK COUNTY TECHNICAL EDUCATION AND TRAINING AUTHORITY**

WHEREAS, the Board of County Commissioners of Sedgwick County, Kansas adopted Resolution No. 173-2004 on September 22, 2004, creating the Sedgwick County Technical Education and Training Authority (SCTETA); and

WHEREAS, the Board of County Commissioners amended Sedgwick County Resolution No. 173-2004 on November 15, 2006 with Sedgwick County Resolution No. 165-2006, restructuring the membership of SCTETA; and

WHEREAS, pursuant to Sedgwick County Resolution No. 165-2006, the Board of County Commissioners is entitled to one appointment to SCTETA; and

WHEREAS, Commissioner Karl Peterjohn desires to step down from SCTETA effective immediately; and

WHEREAS, the Board of County Commissioners of Sedgwick County desires to appoint James M. Howell, Commissioner, Fifth District, to serve as the County Commission appointment to SCTETA for the balance of Commissioner Peterjohn's appointment, or until Commissioner Howell's successor is appointed by resolution of the Board of County Commissioners; and

WHEREAS, it is the desire of the majority of the Board of County Commissioners to consent to said appointment per resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that Commissioner James M. Howell is hereby appointed to SCTETA to serve until June 30, 2016, or until his successor is appointed by resolution of the Board of County Commissioners.
