RESOLUTION ESTABLISHING PARKING RESTRICTIONS ALONG THE 39th STREET SOUTH RIGHT-OF-WAY FROM 100 FEET EAST OF THE EAST ENTRANCE TO LAKE AFTON PARK TO 100 FEET WEST OF THE WEST ENTRANCE TO LAKE AFTON PARK, AND PROVIDING FOR THE ENFORCEMENT THEREOF.

WHEREAS, the Board of County Commissioners of Sedgwick County, Kansas, pursuant to K.S.A. 8-2001, et. seq., has the power and authority with respect to streets and highways under their jurisdiction and within the reasonable exercise of the police power to enact and enforce resolutions regulating traffic, said resolutions relating to those subjects enumerated in K.S.A. 8-2002; and

WHEREAS, pursuant to K.S.A. 8-2002(a)(1), the Board of County Commissioners of Sedgwick County, Kansas, is authorized to regulate or prohibit parking; and

WHEREAS, pursuant to K.S.A. 8-2002(a)(1), the Board of County Commissioners of Sedgwick County, Kansas, determines, on the basis of an engineering and traffic investigation performed by the County Engineer of Sedgwick County, Kansas, that parking along 39th Street South from 100 feet east of the east entrance of Lake Afton Park to 100 feet west of the west entrance to Lake Afton Park be regulated or prohibited.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:

- SECTION ONE: Parking be prohibited at all times on both sides of 39th Street South from 100 feet east of the east entrance of Lake Afton Park to 100 feet west of the west entrance to Lake Afton.
- SECTION TWO: The parking prohibitions shall be signed as directed in Section One, thereof, and the prohibitions shall be for the public right-of-way in its entirety.
- SECTION THREE: The County Engineer is hereby directed to erect official traffic control devices as may be most appropriate, giving notice of the parking prohibitions and hours of effectiveness, if necessary, established by this resolution; and that said traffic control devices be in conformity with the most recent edition of the Manual on Uniform Traffic Control Devices for Streets and Highways.
- SECTION FOUR: All law enforcement officers with jurisdiction in Sedgwick County, Kansas, are hereby authorized to enforce the parking prohibitions contained in Section One, hereof, which have been properly signed as directed in Section Three, hereof.

SECTION SIX: Any person who shall violate any parking prohibition in this resolution shall be guilty of a misdemeanor as provided by law.
