**A RESOLUTION APPOINTING CINDY WEBER TO THE  
SEDGWICK COUNTY INTELLECTUAL AND DEVELOPMENTAL DISABILITIES

WHEREAS, Sec. 14-111 of the *Sedgwick County Code* provides for the appointment of members to the Sedgwick County Intellectual and Developmental Disabilities Advisory Board and their terms of appointment; and

WHEREAS, a vacancy has been created on the Sedgwick County Intellectual and Developmental Disabilities Advisory Board due to the January 17, 2016 expiration of the regular term of Wendy Lee, one of Commissioner Unruh's appointments; and

WHEREAS, it is the recommendation of Commissioner Unruh that Cindy Weber be appointed to the Sedgwick County Intellectual and Developmental Disabilities Advisory Board, effective February 17, 2016.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that Cindy Weber is hereby appointed to the Sedgwick County Intellectual and Developmental Disabilities Advisory Board. The term of this appointment shall expire February 16, 2020, except that in the event the Commissioner making the recommendation for the appointment herein leaves office for any reason, the said term shall expire and the member shall then serve until a successor has been duly appointed.


