**A RESOLUTION MODIFYING CHAPTER 14, DIVISION 2, SECTION 76 OF
THE SEDGWICK COUNTY CODE AND ALTERING THE MEMBERSHIP
OF THE MENTAL HEALTH ADVISORY BOARD BY RESCINDING
RESOLUTION NO. 137-2001**

WHEREAS, the Board of County Commissioners of Sedgwick County, Kansas, has provided for a community mental health center pursuant to K.S.A. 19-4001 et seq.; and

WHEREAS, the Board of County Commissioners of Sedgwick County, Kansas, has established, pursuant to K.S.A. 19-4002a and Sedgwick County Resolution No. 199-1986, a mental health advisory board to make certain recommendations regarding mental health services and programs in Sedgwick County; and

WHEREAS, the Board of County Commissioners of Sedgwick County, Kansas, desires to eliminate the two at-large positions of the Mental Health Advisory Board, reducing the number of appointees to fifteen (15); and

WHEREAS, the Board of County Commissioners of Sedgwick County, Kansas, desires to rescind Resolution No. 137-2001, resulting in a modification to Chapter 14, Division 2, Section 76 of the Sedgwick County Code.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that Chapter 14, Section 76 shall, in its entirety, read as follows:

Sec. 14-76. – Membership; appointment and term of members.

Pursuant to K.S.A. 19-4002, the board of county commissioners shall appoint a mental health advisory board, the members of which shall be, as nearly as possible, representative of public welfare, hospitals, mental health, and mental disability organizations, and education, rehabilitation, labor, business and civic groups. Said board shall consist of fifteen (15) members who shall serve at the pleasure of the board of county commissioners and be appointed as follows:

- (1) Each county commissioner shall appoint three members to said advisory board. The members appointed shall serve for a period of four (4) years from the date of appointment. In the event that the commissioner recommending the appointment of said member leaves office for any reason, said term shall expire, except that a member so appointed may continue to serve until a successor has been duly appointed.

(2) In the event of the death, resignation, or disqualification of any member, such member's successor shall be appointed as herein provided to fill only the unexpired term caused by such vacancy.

This resolution shall take effect upon passage.


