On the recommendation of Kristen McGovern, on behalf of Facilities Department, Linda Kizzire moved to **extend the current contract for an additional one** (1) **year term.** Tim Kaufman seconded the motion. The motion passed unanimously.

Note: The original contract amount/time was for \$53,760.00 per year and four (4) years. The extension of 1 year represents a 25% increase to the original contract term.

This service provides chemical testing and treatment recommendations for all closed and open loop HVAC systems under the responsibility of Facilities Maintenance including: Adult Detention, Regional Forensic Science Center, Historic and Main Courthouse, Juvenile Court, Munger Building, Public Safety, and Work Release.

The vendor provides monthly testing with additional weekly and/or bi-weekly testing being conducted by county maintenance staff to ensure proper continued functioning of each system. Upon completion of testing a recommendation report is submitted monthly for county staff to determine appropriate chemical purchasing needs.

Question: Is the \$53,760.00 the same price for the contract extension?

Answer: Yes.
