WITNESSETH:

WHEREAS, County, through its Department of Corrections, maintains and operates the Sedgwick County Juvenile Detention Facility (JDF), the Sedgwick County Juvenile Intake and Assessment Center (JIAC), the Sedgwick County Juvenile Residential Facility (JRF), and the Sedgwick County Youth Program (SCYP) (collectively the "Facility"); and

WHEREAS, County is required to provide residents of the Facility with professional medical services, pursuant to K.A.R. §§ 28-4-356, 28-4-279, and 28-4-275 and mandates of the Kansas Department of Corrections; and

WHEREAS, on July 1, 2015, the parties entered into a one-year Agreement for the provision of said professional medical services; and

WHEREAS, pursuant to Section XII of that Agreement, the parties have a right to amend that Agreement upon mutual agreement; and

WHEREAS, due to unexpected staffing changes, the parties agree that it is in their best interest to enter into an extension of the Agreement.

NOW, THEREFORE, in consideration of the promises and mutual agreements hereinafter contained, County and Society hereby agree as follows:

Beginning and Ending Dates of Agreement. The parties agree that the language of Section I of the Agreement shall be amended to read as follows:

Subject to the other provisions of this Agreement, the term of this Agreement shall commence on July 1, 2015, and terminate on December 31, 2016. This Agreement may be canceled by either party at any time, with or without cause, upon thirty (30) days prior written notice. When this contract expires, CORPORATION shall not incur new obligations for the terminated portion after the effective date of the termination and shall cancel as many outstanding obligations as possible. COUNTY shall allow full credit to CORPORATION for

the non-cancelable obligations properly incurred by CORPORATION prior to notice of expiration.

All other terms and provisions of the original Agreement will remain in effect as written.
