**A RESOLUTION AUTHORIZING PARTICIPATION IN THE CHIEF ELECTED

WHEREAS, Congress enacted the Workforce Innovation and Opportunity Act (WIOA) in 2014; and

WHEREAS, Sedgwick County is located in Local Area IV for the State of Kansas and may participate in the Chief Elected Officials Board (CEOB) created under WIOA; and

WHEREAS, Sedgwick County desires to participate in the CEOB and may appoint two (2) members to serve on the CEOB; and

WHEREAS, it is the recommendation of the Sedgwick County Board of County Commissioners that Commissioner James Howell and Commissioner Dave Unruh be appointed to the CEOB for a term of three years to commence August 10, 2016 and expire on June 30, 2019.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that Sedgwick County shall participate in the Chief Elected Officials Board for State of Kansas Local Area IV and Commissioner James Howell and Dave Unruh are hereby appointed to the CEOB for a term of three years to commence August 10, 2016 and expire on June 30, 2019.
