A RESOLUTION PURSUANT TO K.S.A. 12-520¢ TO FIND AND DETERMINE THAT THE PROPOSED ANNEXATION BY THE CITY OF VALLEY CENTER WILL NOT HINDER OR PREVENT THE PROPER GROWTH AND DEVELOPMENT OF THE AREA OR THAT OF ANY OTHER INCORPORATED CITY LOCATED IN SEDGWICK COUNTY

WHEREAS, K.S.A. 12-520c sets forth a procedure where a city may request the Board of County Commissioners (the Board) to find and determine whether a proposed annexation by the City of Valley Center (the City) will hinder or prevent the proper growth and development of the area or that of any other incorporated city located in Sedgwick County; and

WHEREAS, on July 28, 2016, the clerk of the City submitted a certified copy of City Resolution No. 654-16 requesting the Board make the statutory finding; and

WHEREAS, on August 16, 2016, the City adopted Resolution No. 657-16 to modify the proposed annexation to also include the entirety of the road rights-of-way of the portions of Meridian Street and 93rd Street North that are proposed to be annexed; and

WHEREAS, the Board, after considering the information provided, has found and determined that the proposed annexation by the City will not hinder or prevent the proper growth and development of the area or that of any other incorporated city located in Sedgwick County;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, THAT THE CITY BE NOTIFIED OF THESE FINDINGS AND DETERMINATIONS:

- **Section I.** On July 28, 2016, the clerk of the City filed with the Sedgwick County Board of County Commissioners a certified copy of Resolution No. 654-16, pursuant to K.S.A. 12-520c. Resolution No. 654-16 was then modified by Resolution No. 657-16. The Board considered this matter at its regular agenda on August 24, 2016.
- **Section II.** The land proposed to be annexed is located entirely within Sedgwick County, and it is generally described as land located near the intersection of 93rd Street North and Meridian, and is specifically described in the City's resolution cited in the above section.
- **Section III.** The owner of the land described, Unified School District No. 262, has approved a Motion and Resolution for Request for Annexation, Resolution #14-16, in order to request annexation into the City.

Section IV. The Board hereby finds and determines that sufficient information has been presented to the Board to support a finding that the proposed annexation will not hinder or prevent the proper growth and development of the area or that of any other incorporated city located in Sedgwick County; and therefore, the Board finds and determines that based on the available evidence, the proposed annexation will not hinder or prevent the proper growth and development of the area or that of any other incorporated city located in Sedgwick County.

Section V. This resolution will take effect upon its passage. The County Counselor's office is directed to send a copy of this resolution by mail to the City of Valley Center.
