A RESOLUTION OF THE BOARD OF SEDGWICK COUNTY, KANSAS  
COMMISSIONERS ACCEPTING THE RESIGNATION OF JAMIE OEERST, M.D.,  
AND APPOINTING TIMOTHY S. GORRILL, M.D., Ph.D., AS THE SEDGWICK  
COUNTY DISTRICT CORONER

WHEREAS, on December 17, 2008, this Board promulgated Resolution 193-2008, duly appointing Jamie Oeberst, M.D. as Sedgwick County District Coroner, and renewed her appointment to a four-year term in Resolution 193-2012 on December 19, 2012; and

WHEREAS, the current term of Jaime Oeberst, M.D. as the Sedgwick County District Coroner, expires January 8, 2017; and

WHEREAS, it is the desire of Dr. Oeberst to resign as the Sedgwick County District Coroner; and

WHEREAS, pursuant to K.S.A. 22a-226, the local medical society nominated Timothy S. Gorrill, M.D., Ph.D., to serve as District Coroner; and

WHEREAS, the Sedgwick County Board of County Commissioners, having found that he is a resident of the state of Kansas who is licensed to practice medicine by the state Board of Healing Arts, desires to appoint Timothy S. Gorrill, M.D., Ph.D., to the position of District Coroner for Sedgwick County, Kansas, to complete the current four-year term pursuant to the authority granted by K.S.A. 22a-226, which began January 14, 2013 and will end January 8, 2017.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS :

Section 1. The resignation of Jamie Oeberst, M.D., is accepted.

Section 2. Timothy S. Gorrill, M.D., Ph.D., is appointed as the Sedgwick County, Kansas District Coroner, to complete the four-year term that began January 14, 2013, and will end January 8, 2017.
