On the recommendation of Kristen McGovern, on behalf of Public Works, Tim Kaufman moved to **accept the bid from Andale Construction, Inc. in the amount of \$477,354.08**. Jennifer Dombaugh seconded the motion. The motion passed unanimously.

Sedgwick County opened bids for the 2016 Super Seal – Phase 2 (Project R342-B) on February 7, 2017, Andale Construction, Inc. was the sole bidder on the project. Public Works has reviewed the bid and recommended that the scope of the project be modified prior to award of the contract. They recommend elimination of the following original bid items:

1. HMA Surface (Ultrathin Bonded)(Type A)(PG 64-22)
2. Pavement Marking (Paint)(White)(4")(0.024")
3. Pavement Marking (Paint)(White)(6")(0.024")
4. Pavement Marking (Paint)(Yellow)(4")(0.024")
5. Pavement Marking (Paint)(White)(24")(0.024")
6. Pavement Marking Symbol (Paint)(White)(Left Arrow)(0.024")
7. Pavement Marking Symbol (Paint)(White)(Right Arrow)(0.024")
8. Pavement Marking Symbol (Paint)(White)(Thru-Right Arrow)(0.024")
9. Milling

Andale Construction, Inc. is currently the only vendor experienced in this process.

This application method for Super Seal has been in existence and practice worldwide for decades but has not been used in this area until recently. There is only one contractor in the local market who is equipped and experienced in this application method. Public Works continues to monitor the cost of this type of application against the cost of other methods and materials, that provide a similar end product to ensure that the county is getting the best possible value.

Questions and Answers

David Spears – This is a partnering project Rockford Township and the City of Derby. I think Rockford will pay \$34,000.00 of that and the balance will be split between Derby and Sedgwick County. We have been working on this for about a year.

Tim Kaufman – So the additional work that is being removed from the bid will be done by Public Works – painting and striping?

David Spears – We will do that on another contract that is called Nova Chip. We are doing 80 miles of Nova Chip this year, so we will add this to that Nova Chip program and will probably get it cheaper like McDonald's hamburgers when we put it with that rather than just one mile here. Derby has a max on what they can pay on a project, and if we had done that, that would have sent us over.

On the recommendation of Kara Kingsley, on behalf the Division of Corrections, Jennifer Dombaugh moved to **accept the proposal from University of Kansas School of Medicine - Wichita Medical Practice Association for an annual cost of \$240,056.00 and establish contract pricing for three (3) years with two (2) one (1) year options to renew.** Tim Kaufman seconded the motion. The motion passed unanimously.

A committee comprised of Mario Salinas and Steven Stonehouse - Corrections, Brenda Gutierrez-Varela - COMCARE and Kara Kingsley - Purchasing reviewed and evaluated the response and unanimously agreed to recommend the University of Kansas School of Medicine - Wichita Medical Practice Association. This contract will provide medical services to Juvenile Detention Facility, Juvenile Residential Facility and the Sedgwick County Youth Program.

Vendors who did not submit a response were contacted and asked why they choose not to respond. The reasons given were that the solicitation was outside of their area of expertise, are currently too busy to add additional clients and staffing issues.

University of Kansas School of Medicine - Wichita Medical Practice Association is the current contracted vendor for these services.

Questions and Answers

Tim Kaufman – Can someone help me understand how this is priced? Is this a fee for service with a cap or is it all inclusive?

Mario Salinas, Administrative Manager for Division of Corrections – The pricing is broken down by a full time physician that is available once a week that supervises the medical services program and they provide an APRN and LPN five days a week and they have on-call services and they also included pricing as far as on-call services and any missed billing.

Zix is a seamless encryption software suite that automatically scans email sent from internal users and encrypts any data being sent in the email that may be confidential or pose a security risk. ITS staff manages the software and sets the criteria in which email is encrypted for data such as HIPAA, CJIS and other personal protected information.

Questions and Answers

David Spears – We have bridges and they have a number. The number sometimes looks like a Social Security number. And so when we are sending that – they can't get it. So it causes us a problem but we got it figured out. I think it was the system that stopped it. It is understandable – it is a security thing.

Tim Kaufman – Do we know how this compared to last year's pricing?

It is really a great deal – better than the one we were getting here. Everybody did a great job finding this and we really appreciate it.
