**A RESOLUTION APPOINTING COMMISSIONER DAVID DENNIS TO THE

WHEREAS, the Lake Afton Public Observatory By-Laws were adopted on December 20, 1979, and amended by the First Amended and Re-Stated By-Laws of the Lake Afton Public Observatory Board of Trustees on February 26, 2016, regarding Articles I – VII; and

WHEREAS, it is the recommendation of Commissioner Dave Unruh, Chairman, that Commissioner David Dennis be appointed to the Sedgwick County Lake Afton Public Observatory Board of Trustees

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:**
