

**FIRST AMENDMENT OF AN AGREEMENT
BETWEEN THE CITY OF WICHITA, KANSAS AND SEDGWICK COUNTY, KANSAS**

2016 Kansas Internet Crimes Against Children (ICAC) Task Force Award

This First Amendment is made and entered into this ____ day of June, 2017 by and between Sedgwick County, Kansas, hereinafter referred to as COUNTY, and the CITY of Wichita, hereinafter referred to as CITY, both of Sedgwick County, State of Kansas.

WITNESSETH:

WHEREAS, COUNTY is the recipient of a grant award from the United States Department of Justice for funding the Internet Crimes Against Children (ICAC) program operated by the Exploited and Missing Child Unit (EMCU);

WHEREAS, on October 12, 2016, the CITY and COUNTY entered into an Agreement ("Agreement") in which COUNTY granted to the CITY, as sub-grantee, funds to be used for staff and vehicle costs incurred by the CITY in the ICAC program;

WHEREAS, this First Amendment is made under the authority of K.S.A. 12-2908, which authorizes municipalities to contract with other municipalities to perform any governmental service, activity or undertaking that each is authorized by law to perform;

WHEREAS, the ICAC commander was recently notified by federal ICAC program management that the ICAC grant award period would be extended from June 30, 2017 to September 30, 2017; and

WHEREAS, the CITY and COUNTY believe it to be in their best interests to extend the date for which the funds covered by the Agreement may be used.

NOW THEREFORE, in consideration of the mutual covenants, conditions and promises contained herein, the parties hereto agree to amend the Agreement as follows:

I. Section 2 of the Agreement is hereby revised to read as follows:

CITY agrees to use \$142,467.00 for the staff and vehicle costs related to the Internet Crimes Against Children Taskforce for the grant period of July 1, 2016 through *September 30, 2017* and in so doing will comply with all grant requirements as stipulated in the Cooperative Agreement included in Attachment B to the Agreement.

II. All other terms and conditions of the Agreement are retained and shall remain in full force and effect and shall govern the actions and obligations of the parties unless specifically accepted or otherwise noted above.


